## **FEMA Offers Repair, Rebuilding Advice at Local Community Facilities in Hoke County**

**RAEFORD, N.C.** – FEMA mitigation specialists will be on hand next week at four local community facilities to answer questions and offer home improvement tips along with proven methods to prevent or reduce damage from future disasters. They also will offer tips and techniques to build hazard resistant homes.

Most of the information and the free publications provided are geared for do-it-yourself work and general contractors.

Recovery topics to be covered include flood insurance, elevating utilities and rebuilding flooded homes.
